NEWPORT BEACH POLICE DEPARTMENT LIMITED AUTHORIZATION FOR ARREST

I hereby authorize the Newport Beach Police Department ("NBPD") to arrest any person who trespasses upon my property located at _____. I specifically designate the Newport Beach Police Department as my agent and grant authority to NBPD Police Officers to request persons who are trespassing to leave the above reference property pursuant to Penal Code section 602(o) when either (1) there is a fire hazard or the owner, owner's agent, or person in lawful possession is absent from the property, or (2) the property is closed to the public and posted as being closed with "Closed to the Public, No Trespassing." If an individual refuses to comply, it shall constitute a trespass under Penal Code Section 602(o). I agree to cooperate fully with any prosecution brought by or on behalf of law enforcement authorities acting at my request and I agree to appear in court if called to do so. I will hold harmless the City of Newport Beach for their actions as a result of this request. **This authorization is valid upon execution before a notary and expires 12 months (365 days) after the date of its execution unless terminated earlier.** I may terminate this authorization when NBPD receives my written request addressed and mailed first class, or hand delivered, to the NBPD Front Desk, 870 Santa Barbara Dr., or upon my email sent from the email address contained on this authorization to records@nbpd.org. Additionally, this authorization expires upon transfer of ownership or upon a change in the person in lawful possession of the property. I agree to immediately notify the NBPD in the event I sell or relinquish ownership, agency or lawful possession of the property. I further understand that it will be my responsibility to request another authorization for arrest once this authorization expires or is terminated.
